6) What sitting Supreme Court justice do you most admire and why?

Judge Krause---As a young attorney, I recall appearing in front of Judge Krause, and because I was always so aggressive in my bail arguments, I remember how patient she was in allowing me to continue to argue even after she made a decision on bail, where I would say, "Judge, understanding your decision, but can you keep in mind that my client would..." and she would look at me with her "silent, non-verbal look of approval" that she understood my continuous argument and the need to make a record, and she didn't "shut me down." I admired Judge Krause because she was *respectful*. Oftentimes during my 25 years of practice, I have appeared in front of judges who, although they understand that attorneys are required to "zealously" represent their clients, they frequently interfered.

Judge Larry Martin---During my tenure as an attorney, I've had the privilege of appearing in front of Judge Martin for motion calendar, as well as for both criminal and civil trials. I admired Judge Martin for the manner in which he handled the trials, more particularly, a specific trial that involved young men, (3), charges with armed robbery. With the trial being extremely emotional, he maintained calm in the courtroom. I admired his courtroom management with the number of defense attorneys, prosecution, and the defendants and their family. I was privy at the time to witness and appreciate the smoothness in his management of the various objections, making of record and his time management to accommodate the jurors and due process.

Judge Schack---I appeared in front of the late Judge Schack in both Criminal Court and Civil Court. In Criminal Court, some described Judge Schack as "tough." Judge Schack followed the law, plain and simple. I admired him for that. Judges are able to use discretions but they must follow the letter of the law. During my appearances in front of Judge Schack in Civil Court, he had his computer on his desk and if you cited a case that he didn't know, he looked it up. He was prepared, his courtroom was efficient and to me, he was pleasant and fair. He had his expectations of attorneys that appeared in his courtroom, and those of us that appeared in front of him knew that we had to be prepared.

Judge Hinds-Radix---I appeared in front of Judge Hinds-Radix in Criminal Court and Civil Court. In either court, I knew when I made an argument in front of Judge Hinds-Radix, that she was *listening*. Most importantly, listening to both sides. In both courts, she asked and inquired further if she saw a need. There's usually the premise that a judge is either pro prosecution/plaintiff or defense/defendant, however, judges are required to not be one-sided. Judge Hinds-Radix was also always very pleasant. If she had a bad day, I never saw it on any of the occasions I appeared in front of Judge Hinds-Radix.

What I have learned from the Judges that I mentioned above and many more that I have appeared in front of over the last 25 years of practice is that it is important to be respectful, impartial, temperamental and provide equal justice to all!
