1) Why do you seek an endorsement from CBID?

In March of 2020, we were tested as a nation and as a city like never before. Our healthcare system, retailers, transportation operation, financial sector, education apparatus, sports and recreation centers, tourism, etc., all felt the full brunt of an unrelenting and unforgiving pandemic. Unfortunately, there was a certain degree of governmental ineptitude which compounded the problem. Many lives were lost unnecessarily due to bureaucracy, in-fighting, egomania, and incompetence.

As New Yorkers, we deserve better. I am running for Congress because my qualifications satisfy the three main criteria: I am willing to serve, able to serve, and ready to serve the as the congresswoman for New York's 10th Congressional District.

With over 2,000 unique volunteers, all of which were never involved in a movement to take control of their futures, I am the fresh new voice New York never knew it needed.

As a mother of three, that resides in New York #10, attended high school and college (NYU) in New York #10, helped the residents and small business owners recover from Superstorm Sandy as a federal emergency management official in New York #10; it would be an honor to serve and receive your endorsement.
