#### 1) Why do you seek an endorsement from CBID?

We should be exploring alternative energy that is efficient and scalable, and work on transitioning as attitudes change, and the alternative energy space evolves. Right now, the least environmentally taxing and most powerful and reliable energy source is atomic energy.

#### 6) What health care reforms or plans do you support?

I support the allowance of Medicare to negotiate with drug companies.

7) Do you support repealing the Senate filibuster? If so, how will you use your platform to push for this reform?

#### 10) What actions do you support to protect our immigrant neighbors?

I support all paths to legal immigration. We are a city and a nation of immigrants. Furthermore, the extension of visas to foreign students ought to be met with less residence. For example, it's in our national best interest to make it easy for an MIT graduate to stay in our country once they graduate. This has not been the case, amazingly.

#### 11) What steps do you support to reform our criminal justice system?

As an endorsed candidate of New Yorkers for Safer Streets, I must emphasize the critical situation we are in right now. Many idealistic reforms that may have been drawn up with good intentions, have backfired horribly. I plan to shutdown mismanaged homeless shelters linked to neighborhood violence, foster the renewal of respect between the community and the NYPD, and would support any state law maker's attempt to repeal bail reform.

I would encourage NYCHA to spend more on their buildings and construction rather than the outrageous "consulting fee" they take out of the budget each year.
